Apply Material by Using:

Hand trowel application using a pool trowel or square edge trowel.

Hydraulic spray equipment (i.e. Graco M680/M340 mortar pump or 9.1 WIWA 410 pump) followed by troweling create required finish.

CLADLINER topcoat can be applied as soon as surface is firm enough to accept a trowel application. Full cure is not required.
